Product Information:

Properties:

– for removing algae organic growth, mildew and moss

Application:

on porous mineral surfaces such as stone, concrete, plaster or bricks

The detergent is used for the effective, sustainable removal of moss and algae. Treating the greened areas destroys the green growth and prevents any further roots and spore formation. If used properly, the surrounding plants will not be damaged.

Impregnation of the cleaned surfaces is recommended in order to permanently prevent renewed soiling by moss and algae.

To remove normal greening, the detergent is diluted with water in a ratio of 1: 3. The surfaces to be worked on must be absolutely dry.

The detergent is generously sprayed or brushed onto the dry surface to be treated.

After approx. 3 - 5 days, the dead algae can easily be loosened with a broom. In case of stronger algae organic growth repeat the application or use ALGENTFERNER - KONZENTRAT (ALGAE REMOVER CONCENTRATE).

Do not dispose of with the household waste! Dispose of product residues in hazardous waste dump or collection points for hazardous substances! Do not allow the material to enter the drainage system, water courses or soil.

Keep out of reach of children. Wear chemical resistant gloves. In case of contact with the skin immediately rinse with plenty of water and soap.

Always carry out a preliminary test to determine the compatibility of the substrate to be treated and to determine consumption.
