Simple green growths are already successfully treated at a mixing ratio of 1:10 with water. Black algae and lichen in particular must be treated in the strong product concentration of 1:5. Green growth will have disappeared completely after a few days, whereas red and black algae need several months to show significant improvement. Heavily infested areas with lichen formation can take up to 2 years until they are cleaned without residue. Here it is essential to ensure that the product concentration is dosed correctly.

Impregnation of the cleaned surfaces is recommended in order to permanently prevent renewed soiling by moss and algae.

Apply the solution only to dry surfaces.

After application, no rain should fall on the treated surface for at least 8 hours.

The active ingredient must bond with the surface for a few hours, so under no circumstances should it be rinsed with water.

Do not dispose of with the household waste! Dispose of product residues in hazardous waste dump or collection points for hazardous substances! Do not allow the material to enter the drainage system, water courses or soil.

Keep out of reach of children. Wear chemical resistant gloves. In case of contact with the skin immediately rinse with plenty of water and soap.

Always carry out a preliminary test to determine the compatibility of the substrate to be treated and to determine consumption.
