Product Information:

Properties:

- dissolved in organic solvents
- very high penetration properties

Application:

for compacted concrete and natural stones

The impregnation is absorbed into the surface, making it water-repellent and deepening the natural color and structure. The surfaces look brighter and fresher, almost as if they were wet. The water-repellent effect reduces the tendency to soiling and stain sensitivity and makes cleaning easier. In outdoor areas, depending on the type of stone and weather conditions, the colour-intensifying effect is maintained for approx. 1 - 2 years, the protective effect lasts for approx. 5 - 7 years.

Can be repainted several times when the effect fades.

DO NOT apply to surfaces that have already been impregnated.

The product is supplied ready to use and can be used without further mixing or dilution.

The application is carried out by using a foam roller.

Drying time:

Walkable after approx. 30 minutes, Complete drying within 24 hours.

To assess the final effect a testing site on the surface which is representative for the final application is imperative.

Quantities to use:

200 - 500 ml/m²

The specified quantities are approximate values because the actual applied quantity does not only depend on the surface structure, but also on the absorbency of the surface.

Avoid direct sun, dust formation or soiling during application. Do not apply if the forecast says says rain during the next 4 hours. Clean tools with thinner.

Application temperature (product and substrate): between +5 °C and +35 °C.

Please note:

Protect plants, glass, polished surfaces, wooden and varnished surfaces, plastics and other sensitive surfaces against splashes.

Under normal storage conditions (closed container, 20 °C) minimum shelf-life 6 months Protect from frost, sunlight, moisture and dirt. Store at temperatures from 5 °C to max. 30 °C.
