Application:

Care of sealed and already laid surface refined concrete slabs

The care product is used on the dry side. Applied as a care product, the dirt and water-repellent effect of the laid, surface-refined tiles is refreshed and gives the tiles a neat appearance. Light, superficial scratches are removed.

The substrate must be clean, dry, free of grease and any substance that could impede the penetration of the product.

The product is applied in one or two passes (wet on wet).

In the case of less absorbent surfaces, no excess product may remain on the surface. This can make the surface scratch sensitive. The order quantity is to be reduced.

Attention: Only apply to water-draining, bedded surfaces (without moisture build-up).

The treated area can be walked on after 8 hours. Rainproof after 24 hours.

To assess the final effect a testing site on the surface which is representative for the final application is imperative.

Stir well before use. Close the container well after each use; the product tends to form a skin on contact with air.

Quantities to use:

30 - 80 g/m²

Depending on the application, depending on the absorbency of the panels.

The specified quantities are approximate values because the actual applied quantity does not only depend on the surface structure, but also on the absorbency of the surface.

Avoid direct sunlight or the generation of dust during processing. Do not apply if rain is forecast within the next 4 hours. The surface temperature should be at least 10 °C and max. 30 °C. Tools shall thoroughly be cleaned with water or put into water immediately after use. Once dried product can hardly be removed.

Under normal storage conditions (closed container, 20 °C) minimum shelf-life 12 months Protect from frost, direct sunlight and contamination.

The storage temperature must not exceed 30 °C. Stir before use.
